



Wyoming Supreme Court Citation Query Usage Agreement

Introduction and Purpose

The purpose of the Citation Query tool is to provide key court information to individuals and organizations to enhance the efficiencies of electronic information propagation, and public safety. All approved usage is contingent upon acceptance of the conditions in this agreement as well as any applicable Federal or State laws. Each individual within an organization who requires access to court information through the citation query tool must sign a copy of this usage agreement and be approved by the Wyoming Supreme Court.

Information dissemination refers to the initial access to as well as subsequent access to, and distribution of, information or statistics obtained from the Statewide Court Information Store (SCIS) system through Citation Query.

Conditions of Use

The Wyoming Supreme Court's Technology Office (hereafter referred to as the CTO) retains the right to impose restrictions and shall maintain exclusive control of access to Citation Query and data therein. Subsequent additions or changes to these conditions may occur without notice. Non-agreement to any of these conditions will void this agreement and access to Citation Query will terminate. This agreement may be terminated without notice by the CTO at any time, for any reason.

The information provided by Citation Query shall be used only by the individual or organizational representative signed on this agreement. The use of Citation Query or information therein by any third party is strictly prohibited. Requests for information or usage of Citation Query by individuals or organizations not present on this agreement are required to have explicit written permission from the State Court Administrator and must sign a separate usage agreement.

Users and organizations shall not furnish their Citation Query username or password to any party for any reason, and must notify the CTO in the event that information is known to be misplaced or compromised. Upon an organizational departure or change, the signed individual shall notify the Court Administrator or CTO of that departure or change. Access is non-transferable.

The SCIS system contains sensitive and/or confidential information. Improper access, usage or dissemination of confidential information in any form will result in termination of services and legal prosecution.

There shall be no expectation of individual or organizational privacy concerning the usage of Citation Query. Use of this system is monitored, including access and search/query criteria submitted.

The point of contact for Citation Query access is the Court Administrator of the Wyoming Supreme Court.
