There are several violations of law which require appearance before a judge. When you have been charged with one of those offenses, or when the arresting officer has reasonable cause to believe that you will disregard your promise to appear in court, the arresting officer will take you to the proper judge without delay.

Wyoming is a member of the Nonresident Violator Compact. If you reside in Wyoming or a member state and fail to post bond or appear in court for a violation of a traffic offense, your driver's license may be suspended.

DISPOSITION PROCEDURE

If the box labeled "MUST APPEAR" is checked on this citation, you are required to present yourself to the designated court on the date and time indicated. If the box labeled "may forfeit bond in lieu of appearance" is checked, this case may be disposed of in one of the following ways:

- (1) Appear before the court as promised and plead "not guilty" which entitles you to: (a) a trial at a future date to be set by the court, (b) an attorney, or a court appointed attorney under certain conditions, and (c) a bond hearing on that date if your trial date is set over to another date. At the trial the burden of proof is upon the prosecution to prove the charge beyond a reasonable doubt.
(2) Appear before the court and plead "guilty" or "nolo contendere" (no contest) and pay the fine and costs as assessed by the judge and/or serve a possible jail sentence. You will be given an opportunity to explain the facts and extenuating circumstances.
(3) Except for offenses requiring your personal appearance, you may avoid a court appearance if you deposit bond and costs fixed by the Wyoming Supreme Court or Municipal Court for the offense for which you are charged. You may post this bond with the court in person or by mail. If you wish to pay by mail, please do so by money order or cashier's check (NO CASH). The payment must be for the exact amount of the bond indicated on the citation and must be received by the Court clerk before the scheduled court date. If mailing payment, please allow adequate mailing time that ensures the court will receive your payment prior to your court date and to avoid the possible issuance of a bench warrant for your arrest should payment not arrive on time. Please write the citation number on the payment and mail it with a copy of the citation to the appropriate court (Campbell County Circuit Court or Gillette Municipal Court), as indicated on the front of this citation.

NOTICE

Failure to comply with one of the above procedures may result in the issuance of an arrest warrant for you with the possible additional charge of "failure to appear".

If you do not sign the below Waiver and Forfeiture, the bond you have posted will be automatically forfeited if you do not appear in court. Bond forfeiture will be treated the same as a conviction by driver's licensing authorities.

WAIVER AND FORFEITURE

I, the undersigned, do hereby knowingly waive my right: (a) to appear before a judge; (b) to an attorney; (c) to a trial, and do hereby voluntarily forfeit bond to the offense charged in the citation, understanding that when I sign below, I do not have to appear before a judge and the case is then disposed of.
